What data do we collect?

Our organisation collects the following data:

• Personal identification information if entered by visitors to our website (Name, email address, phone number, etc.)

How do we collect your data?

You directly provide Our Organisation with most of the data we collect. We collect data and process data when you:

How will we use your data?

How do we store your data?

Our Organisation securely stores your data at our cloud storage facility.

Our Organisation will keep any data you provide for a period of Five years. Once this time period has expired, we will delete your data by removing those records from our cloud storage faciliy.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop Our Organisation from contacting you for marketing purposes or giving your data to other members of the Our Organisation Group.

What are your data protection rights?

Our Organisation would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Our Organisation for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Our Organisation correct any information you believe is inaccurate. You also have the right to request Our Organisation to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Our Organisation erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Our Organisation restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Our Organisation's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Our Organisation transfer the data that we have collected to another organization, or directly to you, under certain conditions.

This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.
